In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 10, 2017 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2017-2018, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 10, 2017 meeting of the Board of Education.

The Grattan staff maintain a safe and orderly learning environment relative to cleanliness, management of the facility and student behavior. We are proud of our comprehensive emergency and crisis response plan and are confident that our systems will support our children in the event of a natural disaster. This Fall the Emergency Response Team did an extensive audit of our plan and made many upgrades. In addition, we are collaborating with the Fire Department to ensure that Grattan has sufficient emergency supplies to not only serve our students but to also be a community asset in case of a natural disaster.

All classroom teachers conduct regular Restorative Practices circles as a means of building and sustaining a positive learning environment. The Grattan philosophy is predicated on the belief that student learning is built atop strong social connectedness and thus the social emotional needs of the students matter. We have participated in professional development activities including conflict management training, health education, crisis management, inclusive practices, restorative practices, culturally response practices, and family diversity and LGBT awareness. We are proud of our school wide positive behavior recognition program, "Caught in the Act".
