#### WHAT IS CALSTRS?

The CalSTRS Pension Plan is a defined benefit plan that provides service retirement benefits calculated using a formula based on age at retirement, years of service and final compensation.

#### ELIGIBILITY RULE

CalSTRS membership is not mandatory for Substitutes however you can elect the pension plan voluntarily. If you elect membership via the Permissive Membership form located in your hire packet, enrollment begins on the first day of employment.

**CONTRIBUTION**

**Social Security:**

If you did not elect membership in CalSTRS, you will see the following Social Security pension deductions and contributions on your paycheck:

- Employee contribution: 6.2% of gross salary.
- Employer contribution : 6.2% of gross salary.
- Maximum amount is subject to change annually.

**Medicare:**

- Mandatory contribution for all employees hired after April 1, 1986
- Employee – 1.45% of gross salary

**403(B) PLAN**
