It is the responsibility of all bidders to notify all subcontractors from whom they request bids and from whom they accept bids of all changes contained in this addendum.

QUESTIONS

1. **“Is the contractor required to keep the existing systems on line for the rest of the sire during construction? These systems include lighting, speakers, security, sprinklers, plumbing, and cameras, online during construction.”**
Response: Yes. See Specifications: 00800 SPECIAL CONDITIONS, 1.8 Utility Work.
2. **“Note 11 on a4.02 showed (n) tables and benches NIC. Is spec section 12640 – booth & tables referred to those tables and benches in cafeteria that is n.i.c.? Is the spec section for reference only? Please confirm.”**
Response: See Project Specification Item 1 below.
3. **“On floor plan sheet a4.02 keynote #12 states tables and benches nic. I assume this means they have been taken out of the general contract and any tables purchased will be done by the district.”**
Response: See Project Specification Item 1 below.
4. **“A 4.02 also shows 4 openings for 4 double recessed pockets. Are these also being taken out of the contract.”**
Response: NO.
5. **“A4.02 shows 6 tables in the eating area. 4 double recessed pockets would provide 8 tables with benches.”**
Response: Contract Documents Floor Plan shows layout with stage. Recess pockets provide maximum number of tables and benches without stage.

6. “What type of light fixture is to be used at the recessed pockets in the cafeteria?.”

Response: No lights are indicated in the recessed pockets. Cove lighting is above the tables and benches storage closets.
