<u>Work</u>. Any Bidder not so duly and properly licensed shall be subject to all penalties imposed by law.

- 7. <u>Bid Security</u>. Each Bid Proposal shall be accompanied by Bid Security in an amount not less than **ten percent (10%)** of the maximum amount of the Bid Proposal, inclusive of any additive Alternate Bid Item(s).
