- **6.** <u>Labor Compliance Software:</u> The District requires the Contractor to use a Labor Compliance Software, Elation Systems, Inc. for the duration of the Project. This cost is to be included in the Total Base Bid amount on the Bid Form, section 00400. - 7. <u>Contractors License Classification</u>. In accordance with the provisions of California Public Contract Code § 3300, the District requires that Bidders possess the following classification(s) of California Contractors License at the time that the Bid Proposals are opened: Class B, General Contractor with Asbestos and Lead Certification or Sub-Contractor with Asbestos and Lead Certification performing the Work. Any Bidder not so duly and properly licensed shall be subject to all penalties imposed by law.
- **8.** <u>Bid Security.</u> Each Bid Proposal shall be accompanied by Bid Security in an amount not less than **ten percent (10%)** of the maximum amount of the Bid Proposal, inclusive of any additive Alternate Bid Item(s). Failure of any Bid Proposal to be accompanied by Bid Security in the form and in the amount required shall render such Bid Proposal to be non-responsive and rejected by the District.
- **9.** No Withdrawal of Bid Proposals. Bid Proposals shall not be withdrawn by any Bidder for a period of ninety (90) days after the opening of Bid Proposals. During this time, all Bidders shall guarantee prices quoted in their respective Bid Proposals.
- **10.** <u>Job-Walks</u>. The District will conduct a **MANDATORY** job walk as set forth herein. There will be one job walk as indicated below. Attendance at the job walk is a requirement to bid for General Contractors. All attendees are required to sign-in to be acknowledged to be in attendance and eligible to bid.
