REQUEST FOR QUALIFICATIONS for LANDSCAPE DESIGN SERVICES

The San Francisco Unified School District 2006 & 2011 Proposition A Bond Green Schoolyard Program will receive Statements of Qualifications (SOQ) in Room 216, 135 Van Ness Avenue, San Francisco, California, 94102 on **WEDNESDAY, APRIL 25, 2012 BY 2:00 PM** for various projects requiring landscape design services. The estimated construction value of the work for each of these projects is approximately \$100,000, and assumes a 10% construction contingency for unforeseen conditions.

The following school sites require landscape design professionals to develop designs that reflect the greening priorities outlined in their respective RFQs:

2. Chinese Immersion School (at DeAvila)
3. Cleveland Elementary School
4. Dr. George Washington Carver Elementary School

*In addition to Landscape Architecture services, this project will require the services of a licensed architect, having experience with the Division of the State Architect department.

Landscape architecture firms with strong experience designing green schoolyards, parks and/or outdoor recreational spaces including experience with the Americans with Disabilities Act should apply. Requirements for applicants include: a) Landscape Architect License (State of California); b) A minimum of two (2) years experience in the design of green schoolyards, educational settings, and ecological landscape design; and, c) Experience in access design for educational settings.
