**3t. 124-24W20, page 56** – That the Board of Education approve this contract between either All Trusty Builders or Aloha Builders and the San Francisco Unified School District for an amount not to exceed \$98,000.00 and instruct the Chief Facilities Officer or designee to sign all documents necessary for the execution of the contract on behalf of the District and to encumber sufficient funds from Proposition A School Repair Program Fund. The final selection shall be through drawn lot by the Board of Education pursuant to the provisions of California Public Contract Code 20117. In the event the district is not able to enter into a contract with All Trusty Builders or Aloha Builders, it will award to the next lowest, most responsive and responsible bidder, or the District may elect to re-bid the project.

Both names (All Trusty Builders and Aloha Builders) were placed in a container by David Goldin, Chief Facilities Officer, and Evelyn Wilson, Board of Education Parliamentarian, drew the name of the winning contractor : **Aloha Builders**. Therefore, the Board of Education voted unanimously to grant the contract to Aloha Builders.
