The Board of Education met in Regular Session on Tuesday, August 26, 2014, at 6:06 p.m. in the Irving G. Breyer Board Meeting Room, 555 Franklin Street, First Floor, San Francisco, California. Presiding: Sandra Lee Fewer, President.
