Vice President Murase read a **correction** to **143-11A4** adopted at the the March 4th Closed Session. The correction reads as follows: Existing Litigation: In the Phase II Retirement Plan Cases (Los Angeles Superior Court Case No. 4685) (PARS Litigation) during its March 4, 2014 Closed Session meeting, the Board by a vote of 5 ayes, 2 absent (Mendoza-McDonnell, Murase) authorized counsel to negotiate and enter a settlement of the litigation on specified terms, including a monetary payment to the District. This corrects the previous readout of the Board’s March 4, 2014 Closed Session action, which erroneously indicated that the Board had authorized a payment ***by*** the District, rather than ***to*** the District.

Vice President Murase read a **correction** to **145-6A8** adopted at the May 6th Closed Session. The correction reads as follows: The Board of Education by a vote of 6 ayes and 1 nay (Fewer) approved the contract of 1 General Counsel.
