

## **BID ADDENDUM NO. 2**

### **Meal Services Invitation for Bid IFB No. MS-2012**

**Due Date: November 13, 2012 at 2:00 p.m.**

**TO: ALL BIDDERS**

Bidders are advised, the following provisions of IFB/contract MS-2012, Meal Services, as amended by Addendum No.1, have been further amended by this Addendum No. 2, and will supersede the corresponding terms and/or conditions of the IFB/contract, as amended by Addendum No.1, as set forth in this Addendum No. 2.

All terms and conditions of the IFB/contract, as amended by Bid Addendum No. 1, that are not amended by this Addendum No. 2 shall remain the same as set forth in the IFB/contract as amended by Addendum No.1.

Please note the following changes to the subject Invitation for Bid/contract proposal, as amended by Bid Addendum No. 1, before submitting your offer.

A signed and dated copy of this Bid Addendum No. 2 must accompany your bid.

**1. Section 52(E) (“Route Delivery Tickets”) of IFB/contract MS-2012, as amended by Bid Addendum No. 1, is hereby deleted in its entirety and replaced with the following:**

**E. Route Delivery Tickets; Racking.** The District’s SNS department will design and provide route delivery tickets to Contractor which Contractor shall use in labeling and arranging all meals, meal components and supplies by routes for pick-up at Contractor’s distribution center, unless a different route delivery ticket system is otherwise agreed to in writing by the parties. Contractor shall “rack” the meals, meaning break out the meals from case format and load the meals in 13” X 26” chrome plated baskets designed for use in the District’s CresCor Retherm Heat-N-Hold Ovens, Model RO=151-F-1332B. Although occurring very infrequently, the delivery routes designated by the District are subject to change with a minimum of seventy-two hours’ written notice, and Contractor shall update its operation and paperwork accordingly to match any such changes.

**2. Subsection (C) of Section 68 (“Community Tasting Panel”) of IFB/contract No. MS-2012, as amended by Bid Addendum No. 1, is hereby deleted in its entirety and replaced with the following:**

C. The Community Tasting Panel shall be held on Friday November 16, 2012 from 2:00 p.m. to 4:00 p.m. (or later as needed). The location of the Community Tasting Panel shall be SFUSD’s Tenderloin Elementary School 627 Turk Street, San Francisco, CA, 94102. Bidders shall deliver the required sample meals as described in subsection (F) of Section 68 “(Community Tasting Panel)” to Tenderloin Elementary School, between 9:00 a.m. and 10:00 a.m. on Friday, November 16, 2012. A member of the District’s SNS staff will be present to receive and properly store all meals received upon arrival.

All other terms and conditions in IFB/contract No. MS-2012, as amended by Addendum No. 1, shall remain unchanged.

If you have already submitted a bid, you are required to submit your bid amendment(s) before the bid due date in order to comply with the change(s) indicated above. You must submit your bid amendment(s) together with this Bid Addendum No. 2 signed and dated in a separate sealed envelope stating the IFB/contract proposal number and due date.

This Bid Addendum No. 2 must be signed and submitted as required, otherwise the bid offer shall be deemed unresponsive.

As with the bid, any bid amendments and bid addenda received after the bid due date will not be considered.
