Item Specifics:

- 1. The wire heating rack should**
 - a. Have the following dimensions (or extremely close) 11cm x 9.5 cm x 4cm tall**
 - b. Have a wire mesh top suitable for setting items on top**
 - c. Here is a link to the source item (<http://shop.iat.com/wire-heating-rack/>)**
 - d. The rack item needs to fit a tea candle below it with the appropriate amount of space between the flame and the item above so that it can heat the item.**

The rack needs to be able to hold a 400mL beaker on it without the beaker falling through or tipping over.
