

BID ADDENDUM NO. 2

Transportation Services Invitation for Bid IFB No. TS-2015

Due Date: June 5, 2015 at no later than 2:00 PM PST

TO: ALL BIDDERS

BIDDERS ARE ADVISED:

The San Francisco Unified School District ("District") hereby issues this Bid Addendum No. 2 to the Bid/Contract, as defined below. This Bid Addendum No. 2 modifies Transportation Services Invitation for Bids No. TS-2015, as detailed herein.

EACH BIDDER MUST SUBMIT A SIGNED AND COMPLETED COPY OF THIS BID ADDENDUM NO. 2, TOGETHER WITH ITS BID PROPOSAL, BY THE BID DUE DATE AND TIME, OR THE BIDDER'S BID PROPOSAL MAY BE DEEMED NON-RESPONSIVE.

1. **Definitions.** The following definitions shall apply to this Bid Addendum No. 2 to the Bid/Contract:
 - a. **"Bid/Contract" and "IFB".** The terms "Bid/Contract" and "IFB" shall mean Invitation for Bid No. TS-2015, Transportation Services, issued by the District on May 7, 2015, as amended by Bid Addendum No. 1, issued by the District on May 12, 2015.
 - b. **Other Terms.** Terms used and not defined in this Bid Addendum No. 2 shall have the same meaning assigned to such terms as in the Bid/Contract.
2. **Modifications to the Bid/Contract.** The following provisions of the Bid/Contract are hereby amended by this Bid Addendum No. 2, and supersede the corresponding terms and/or conditions of the Bid/Contract, as set forth in this Bid Addendum No. 2.
 - a. **Section 50 ("Location of Vehicles, Equipment and Local Office") of IFB/contract TS-2015 is hereby deleted in its entirety and replaced with the following:**

50. LOCATION OF VEHICLES, EQUIPMENT AND LOCAL OFFICE

The Contractor shall maintain a local office, bus yard and all necessary vehicles and equipment for the performance of this bid/Contract at a suitable location in San Francisco or in the immediate vicinity of San Francisco which is defined hereunder as being within a ten (10) mile radius and not involving a bridge. The Contractor shall not authorize overnight park-out of any vehicles utilized for the transportation of pupils under this Contract without the prior written permission of the District's Transportation Director. The Contractor shall maintain its bus yard in compliance with California Highway Patrol ("CHP") standards, as demonstrated by holding a current and valid terminal inspection certificate issued by the CHP for the bus yard.

b. Subsection (D) of Section 57 (“Capacity to Perform the Contract”) of IFB/contract TS-2015 is hereby deleted in its entirety and replaced with the following:

- D. Contractor shall have the necessary vehicles, as detailed in Section 49 (“Vehicle Requirements”), to perform the services under this bid/Contract, and according to other requirements of this bid/contract, and in light of any existing business obligations of Contractor.
- a. Each bidder shall submit with its bid proposal documentation of its ability to timely provide the requisite vehicles to perform this bid/contract. Each bidder shall submit with its bid proposal a complete listing of all of the vehicles it proposes to provide to perform this bid/contract, as detailed herein, indicating: (1) make of chassis, (2) make of body, (3) model, (4) type (transit or conventional), and (5) year of manufacture.
 - b. If a bidder will await bid award before entering into a lease or purchase of any vehicles to be used in the performance of the bid/contract, then the bid proposal shall contain a letter or letters of agreement, or an option or options to lease or purchase, or other documentation showing bidder stands ready, if awarded, to immediately and lease or purchase said vehicles for the timely performance of the bid/contract.
 - c. Each bidder shall submit with its bid proposal a detailed implementation plan and schedule with regard to its vehicles, including without limitation any newly-acquired vehicles, to meet the requirements of the bid/contract. Such plan and schedule must include detail demonstrating bidder’s experience and capacity to effectively and timely implement its plan and schedule.

Except as expressly modified by this Bid Addendum No. 2, all of the terms and conditions of the Bid/Contract remain unchanged and in full force and effect as set forth in the Bid/Contract.

EACH BIDDER MUST SUBMIT A SIGNED AND COMPLETED COPY OF THIS BID ADDENDUM NO. 2, TOGETHER WITH ITS BID PROPOSAL, BY THE BID DUE DATE AND TIME, OR THE BIDDER’S BID PROPOSAL MAY BE DEEMED NON-RESPONSIVE.

Any bidder that has already submitted a bid proposal to the District under the Bid/Contract as of the date of issuance of this Bid Addendum No. 2, is required to submit a signed and completed copy of this Bid Addendum No. 2 by the bid due date. If such a bidder will amend its bid proposal as the bidder may deem necessary in order to comply with the modifications made in this Bid Addendum No. 2, such bidder must submit any such amended bid proposal, together with this Bid Addendum No. 2, as above, by the bid due date. The signed and completed copy of Bid Amendment No. 2, along with any amended bid proposal, must be submitted in a separate sealed envelope stating the Bid/Contract proposal number and due date.


