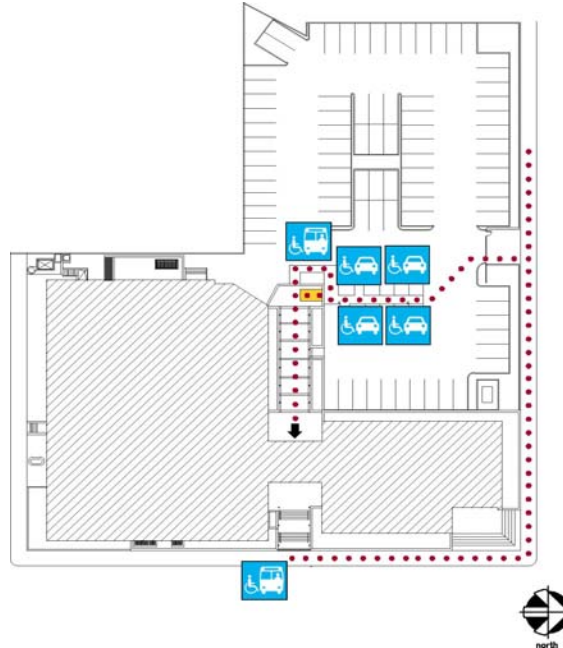

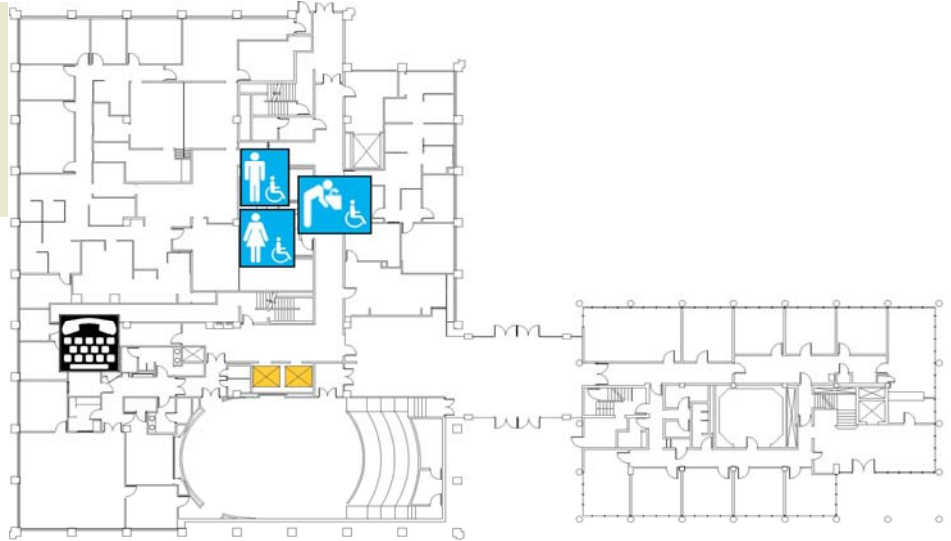
**Parking:**
