All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

### ***For Elementary and Middle Schools (grades K-8)***

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 9, 2018 meeting of the Board of Education.

Lakeshore students (K-3) participate in weekly motor perception lessons. Grades 4 and 5 participate in weekly physical education classes. Weekly gardening lessons and studio art lessons are enjoyed by grades K-5. Our resident poet teaches poetry classes to grades 1-5. In addition, each classroom teacher chooses 20 hours of consultant time which includes drama, cooking, architecture, dance, music, yoga and folk art. Lakeshore partners with The deYoung Museum, The San Francisco Symphony (AIMS I and II), and The San Francisco Ballet Company. Our partnership with PG & E Solar Schools Program supports the teaching of the value of alternative energy. The EXCEL after school program provides extended learning opportunities for students who are identified as needing additional support services
