All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

### ***For Elementary and Middle Schools (grades K-8)***

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 9, 2018 meeting of the Board of Education.

**School Facility Conditions and Improvements**

McKinley was established in 1906-07. The present building, located at 14th Street and Castro, was built in the 1970's. Our central high-beamed library, wooden walls and carpeted modern building set the tone for a warm family-like environment. The diversity of our students and involvement of their families create a friendly and caring community. Our school is clean and attractive and contains 17 classrooms. McKinley meets all the requirements of ADA, including ramps and a working elevator. All student and adult restrooms are in full working order and cleaned several times daily. Gardens surrounding the school are maintained by parents.
