### **School Description and Mission Statement**

This section provides information about the school's goals and programs.

Our primary goal at Gordon J. Lau Elementary is to enable children to become responsible, successful, and contributing members of a global society. We integrate 21st Century skills to help children build strength of character, establish a growth mindset, and to respect cultural diversity. Our classroom lessons are made relevant to real life experiences, so students can apply what they learn to everyday situations. Frequent, ongoing communication with parents is crucial to building trust and a united front with the school for our children's well-being.

The school's support system accommodates all learning modalities. Our staff includes a social worker, a literacy coach/specialist, a Physical Education specialist, a health coordinator, a dance instructor (plus outside consultants to teach traditional Chinese dances), a music instructor, and a computer resource teacher who assists with educational technology. We also collaborate and network with community-based organizations, such as YMCA, Cameron House, Betty Ong Rec Center, Tzu Chi Food Bank volunteers, and SFPD/SFFD, to benefit students and their families.

A school deeply rooted in history, Gordon J. Lau Elementary takes pride in a culturally and ethnically diverse student population. To meet the linguistic and academic needs of our limited English-proficient students, the English Plus and the Chinese (Cantonese) Bilingual Pathways both provide effective academic programs for English Learners. We are committed to validating, promoting, and celebrating cultural and linguistic diversity on a daily basis. At Gordon J. Lau Elementary, all children can and do learn.

All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

### **For Elementary and Middle Schools (grades K-8)**

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

We provide a nurturing learning environment for our students where ethnic, linguistic, and cultural diversity are valued, respected and appreciated. In our strong instructional program we hold consistent grade level academic and behavioral expectations for all students. Our Crisis Response Plan ensures safety for our students in the event of emergencies. We have a Crisis Response Team that met to update emergency practices. We have a Student Study Team (SST), a CARE team, a social worker, and two on-site counselors (who each come 1-2 times a week) to provide support to students and their families. We are currently working on pedestrian/traffic safety issues which include mid-block crosswalks on Clay Street.

**Types of Services Funded (Fiscal Year 2018-19)**

We receive state and federal funds which provide us with the opportunity to fund teachers, Learning Support Consultants (such as a literacy coach and an English Language Development Interventionist), an on-site Social Worker, and to operate After School Learning Programs. In addition, we have our Gordon J. Lau Pre-K Program, a Title I Pre-K class, in which we have 16 students enrolled. The Commodore Stockton Child Development Program is also associated with our school. Many of our students attend either our Pre-K or the Child Development Program. We have several community partnerships, including the YMCA, Cameron House, Chinese Independent Baptist Church, Asian Women Resource Center, Salvation Army, Tennis and Learning Center, Betty Ong Center with Park and Recreation, and Nam Que Chinese School. We receive support from Tzu Chi for our Food Bank Distribution program. We also receive support from Tzu Chi for our Food Bank and Nutrition program.
