In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

School Facility Conditions and Improvements

Fairmount has a unique setting of classrooms in three distinct buildings comprised of pods. We are fortunate to have three playgrounds lined with trees and plants. During 2008-2009, the entire campus underwent a comprehensive ADA modernization. The buildings, pods, and classrooms were painted, bathrooms were updated, and our sinks and counters were replaced. During 2010-2011, the greening component of our \$150,000 Bond Measure began. The yards and grounds surrounding the pods will be further landscaped with the support of this Bond Measure. Our Green Team has been working with landscape architects to increase the sustainability of the school by enhancing its green design. Our school community organizes weekend work days with the objective of cleaning and gardening. This year, we are fortunate to partner with the San Francisco Green School-Yard Alliance. This program provides us a full time Green School-Yard Corps Member, a very talented educator who runs an outdoor environmental learning classroom for all students in Grades Pre K-5. Fairmount is a green school getting greener. All upgrades and modernizations have been and will continue to be ADA accessible.

Types of Services Funded (Fiscal Year 2018-19)

Knowing that our students need support academically, emotionally, and socially, we fund 1.8 Literacy Specialists, full time School Social Worker and Nurse positions, and Playworks for structured engagement at recess and lunch recess. Our Literacy Specialists provide literacy support to students who are performing below grade level standards. Our School Social Worker not only provides direct service to students facing behavioral challenges, but also aligns outside resources for additional support if necessary. Our After School program, Growth and Learning Opportunities (GLO), is aligned with the objectives and content of the school and provides homework support as well. In addition to our School Social Worker, After School Program, and Literacy Specialists, Fairmount is also proud of the services provided by our Instructional Reform Facilitator. This is a teacher leader who works with the staff in providing opportunities for teacher collaboration and instructional planning. Professional Development is also a significant responsibility of the Instructional Reform Facilitator. Our Parent Liaison and Student Advisor work closely with families and our School Nurse works proactively with students and families on the prevention and treatment of illness.
