In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

Guadalupe has been serving the community since 1922. The school has 21 large classrooms with ample storage, a library, a computer lab and wide hallways. The three playgrounds have two play structures and newly installed benches. The multi-purpose room serves as the cafeteria, the auditorium, and a gathering place for the after-school program. The school takes up an entire block in an attractive neighborhood in the Excelsior. It is walking distance from the Crocker Amazon Playground. The #43 bus line stops at the corner. New windows have been recently installed and the building has been freshly painted. Beginning during the 2010-2011 academic year Guadalupe School will be modernized to fully comply with the Americans with Disabilities Act.

School Safety Plan - Most Recent Year

Safety is our first concern. Students are supervised in the yard from 8:20 a.m. until the beginning of school at 8:40 a.m.. A structured dismissal procedure assures safety from school to home or to after-school programs. Lunch is supervised by seven staff members, and teachers feel responsible for all children. All visitors check in at the office and wear badges while on campus.

Fire drills are conducted monthly, and earthquake drills are conducted twice a year. Staff members have been assigned roles on the Emergency Response Team in the event of a natural disaster or criminal act. The Student Assistance Team meets weekly to brainstorm interventions for students of concern. A half-time Learning Support Professional and the faculty focus on prevention and early intervention. Student attendance and punctuality are monitored closely.

They join five staff members in reviewing and school's Balanced Scorecard and budget. All parents are welcome to attend meetings, and Chinese and Spanish translation is available. Wednesday envelopes provide written communication between the school and home. Parent letters are translated into Chinese and Spanish. Several staff members speak Spanish, and one of our elementary advisors speaks Cantonese. Parent volunteers assist in classrooms, the library on the playground, and on numerous field trips. Approximately 90% of our parents attend the Fall and Spring parent-teacher conferences.

Types of Services Funded (Fiscal Year 2018-19)

Title I, SIP and LEP funds provide for a Literacy Specialist 3.5 days a week, and a resource teacher 2.5 days a week to teach computer and P.E. classes. The Guadalupe PTA funds PlayWorks, which provides physical education and structured play activities during morning and lunch recess. The PTA also provides materials for our Visual Thinking Strategies program, and regularly adds to the library collection. The school supports two after-school programs to provide academic support, as well as athletic and enrichment activities. Prop H funds are used to support a twelve week artists-in-residence program. Teachers are provided professional development through workshops, visits to other schools, consultants, and release time to work on curricular projects.
