In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

In Fall 2014, the school modernization was completed, including upgrades to wiring, lighting, wireless and earthquake retrofits as well as ADA upgrades throughout the school building, playground structure upgrades and improved drainage. All students and families have access to the building. Video cameras throughout the building ensure that access and safety are balanced. In addition, our garden is maintained by a committee of teachers and community members. In 2016, the school greening project will be completed, enhancing a green school yard and garden.

There is a Disaster Committee composed of teachers, administrator, student advisor, and ancillary staff. Meetings are held regularly to evaluate our procedures for emergencies. All classrooms have an emergency backpack, and a directory with updated emergency numbers. The office also maintains updated information on all students. Monthly fire drills, annual earthquake and lock down drills provide the entire community with the tools necessary to respond in a crisis.

Types of Services Funded (Fiscal Year 2018-19)

Cesar Chavez Elementary School offers a number of programs including English Language Development, Spanish Bilingual, American Sign Language with spoken English, and special education support with RSP professionals, speech and occupational therapy. Academic RtI includes literacy teachers who work with identified students to accelerate reading gains. Arts education is well-funded and all students receive instruction from art specialists. All students have an opportunity to participate in a variety of enrichment and experiential programs - including overnight camping trips, field trips to museums, cultural events and hands on science and nature exploration. In addition, our school offers after school programs through our ExCEL grant with Jamestown, site funds for Playworks, and after care through community partnerships with Boys & Girls Club, Project Insight (adaptive recreation for deaf/hard of hearing) and Mission Girls Club.
