All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

Rooftop School is located on two campuses, three blocks apart in the Twin Peaks area. The Burnett Campus is home to our K-4 community. The Mayeda Campus houses our 5-8th grade program. Both facilities are routinely maintained by SFUSD Buildings and Grounds Division. Recent construction at the Burnett Campus involved the replacement of old bungalows with permanent modulars set on foundations. Rooftop is currently engaged in the implementation process addressing a parent and staff initiative focused on the playground renewal of the Burnett play yard. A plan to green and renew the Mayeda playground will be undertaken during this year.
