In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

Types of Services Funded (Fiscal Year 2018-19)

In addition to a comprehensive core curriculum that utilizes standards-based programs provided by the district, the school has numerous supplemental programs to support student learning. Orff Music, instrumental music, poetry, art, and a P.E.enrichment program that emphasizes team sports and physical fitness are offered to every class. The Resource Specialist Program offers additional support to students with identified learning disabilities and requiring more individualized instruction. A paraprofessional supports kindergarten and first grade students struggling with early literacy skills through small group interventions and also supports newcomer English Learners. Two special day classes serve students with moderate-servere autism diagnoses. The school also offers other programs such as outdoor education, Visual Thinking Strategies, and Peacemakers.
