School Description and Mission Statement

This section provides information about the school's goals and programs.

At Hillcrest, we believe that all students should be “well-cared for, well-known and well-educated.” We are a community school that focuses on five core elements: a rigorous, student-centered academic program; enriching afterschool and summer programming; physical and mental health services for students and families; family support and engagement; and community collaboration.

We utilize a standards-based balanced literacy model to ensure that all the components of language arts and literacy are addressed. We have adopted a literature-based reader’s workshop curriculum in order to facilitate students’ development as independent thinkers and readers. This curriculum, combined with a comprehensive assessment plan, allows for individualized teaching and learning, and keeps at its core best teaching practices.

Hillcrest provides five different standards-based instructional programs to meet the needs of its very diverse student population. To benefit from this rich linguistic, cultural, and ethnic milieu, the integration of students between classrooms is a daily occurrence.

Spanish Bilingual – This program is designed to ensure that children from Spanish-speaking households develop high levels of English language proficiency and literacy, as well as high levels of academic competency in Spanish.

Cantonese Bilingual – Much like the Spanish Bilingual program, native Cantonese speakers will develop high levels of English and home language proficiency and literacy, as well as high levels of academic competency in Cantonese.

English Language Development – The goal of our ELD program is to empower both English learners and native English speakers to help them to communicate in English more effectively in both written and oral forms, as well as improve their comprehension and listening skills.

Speech and Language and Resource Specialists Programs – With “inclusive practices” at the forefront of instruction, students receive the core curriculum with adaptations and/or modifications that are based on their individual needs.

All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2019-2020, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 6, 2020 meeting of the Board of Education.

Hillcrest has implemented a comprehensive emergency and disaster plan that features a prevention component. A crisis response team has been organized and trained to ensure the welfare of students, staff and building site; monthly fire drills are conducted under the supervision of the San Francisco Fire Department.

Hillcrest is proud of its strong relationships between families, staff and students. All staff members feel a responsibility for all students and their families. We have a very high adult to student ratio on the yard and in the classroom, which means that positive relationships are easier to grow and nurture. We are also a "Caring School Community" school, a nationally recognized, research-based K-6 program that builds classroom and school-wide community. It focuses on strengthening students' connectedness to school, encourages mutual respect and collaborative problem solving. In each classroom you will note a rug dedicated for community meetings that take place at least once a week, if not every day. In addition, a group of 4th and 5th graders participate in a program called Safe School Ambassadors which equips them with nonviolent communication and intervention skills to stop exclusion and bullying at school. All of these programs, on top of the genuinely warm and open manner of our staff results in a calm, warm and happy school environment in which teachers can focus on and be creative in their teaching.

Hillcrest has a well-rounded staff (nurse, learning support consultant, parent liaisons, and a student advisor) to support the emotional, medical, and social needs of our students and families. Hillcrest also partners with Edgewood Center for Children and Families, Instituto Familiar de la Raza, and Access Institute to provide additional therapeutic support to students, teachers, and families. Hillcrest also enjoys robust relationships with Reading Partners, SCORES, Coleman Advocates, the SF EdFund and Experience Corps, which provide a wide array of services to meet our community's needs.

Students at Hillcrest participate in visual and performing arts programming and present their work during family nights and the Youth Arts Festival.

As a Quality Education Investment Act grant recipient, Hillcrest has lowered its class size in the 4th and 5th grades and has hired several literacy teachers.

Teachers receive on-going professional development in literacy through grant-funded collaboration with Columbia University's Teachers College and site literacy coaches.
