All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

### **For Elementary and Middle Schools (grades K-8)**

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2019-2020, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 6, 2020 meeting of the Board of Education.

**Types of Services Funded (Fiscal Year 2019-20)**

This section provides information about the programs and supplemental services that are available at the school and funded through either categorical or other sources.

The PTA pays Strategic Energy Innovations - Climate Corps Education Outside to provide gardening/science enrichment for all elementary students. Salesforce has provided annual grants for the past few years to support educational innovation, provide technology, and promote student achievement. The office of District 4 Supervisor Gordon Mar has provided grants to support STEAM (science, technology, engineering, art and mathematics) education for all students. Special Ed, General Ed and state categorical funds pay for a reading interventionist, Learning Support Professional (social worker), K-8 counselor, and inclusion teachers to support students with IEPs and/or students who are underperforming. Student Assistance Program team members assist students on developing positive peer relationships, achieving academic success, and resolving personal challenges. PRIDE, an after school enrichment program funded by the 21st Century Grant, is available to underperforming students in grades 3 – 8. Visual and Performing Arts as well as PE parcel taxes support art and music as well as PE classes for all students. Parents can privately arrange to have their students participate in Mandarin classes before and after school. They may also register with KEEP to provide active child care services both before and after school for students in K-8.
