All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2019-2020, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 6, 2020 meeting of the Board of Education.

School Facility Conditions and Improvements

We are located on two campuses three miles apart. The Madison Campus features a beautifully restored older wing connected to a nearly new wing, all centered around a sunny courtyard with gardens. The Scott Campus includes a 1930's main building with period architecture and is clean and well maintained. We are challenged at Scott campus with lack of space and long term maintenance, such as the need for painting and repairs. A new roof, new playground, and new green schoolyard space compliment the facility. We have completed all ADA compliance construction. Other modernization and improvements were not included in the construction. We are fully wheelchair accessible. The PTA entrusts funds to SFUSD for technology and high speed internet. Both campuses now have high speed internet in every classroom. The Scott Campus uses 8 detached bungalows as well, with two newly finished murals.

Thanks to the Elementary Arts grant, PTA fundraising, Proposition H funds, and the 21st Century after school program grant, we offer many opportunities for all. They include our partnership with the San Francisco Arts Education Project, Streetside Stories, Outdoor Education, Instrumental Music for grades 4-8, a free after school program for grades 3-8 until 6:00 every day, two open and growing libraries, Korean Language materials, a first rate Physical Education Program for all elementary students, Poets in the Schools, two new computer labs, and more. Six new after school special interest clubs were added this year.
