All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2019-2020, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 6, 2020 meeting of the Board of Education.

School Facility Conditions and Improvements

Spring Valley is the oldest public school in California which was founded in 1852. It's the only school left of the original seven established in 1850. The current building was built after the 1906 Fire & Earthquake and was extensively renovated 15 years ago to be seismic and fire safe. A new roof and new children's bathrooms were installed. The rooms are full of natural light and some new windows installed. Planter boxes were recently built and scattered around the yard for our "Butterfly Garden." The building is networked school wide for computer/technology connectivity & the Internet. Every classroom is equipped with an ELMO and LCD projector to provide better access to instruction to all students. There are two play structures in the recently re-surfaced yard. Our library has automated the book check-out system. The entire campus has been renovated to be ADA-compliant since 2010. Funding has been awarded and plans have been drawn for a "green school yard." This work will begin in 2013.

We are a Science Magnet school with three strands of classes: English only, Chinese & Spanish bilingual up through 3rd grade. 4th & 5th grades are integrated English, GATE cluster classes. There is a Reading Specialist and RSP teacher to instruct children identified as needing additional help in reading and math, Speech Therapist, LSC-Learning Support, Librarian, Computer Tech. & Teacher Aides. Two After School Programs: CDC child care & ACE/Beacon.

Spring Valley receives funds/programs in addition to the General Fund: Title 1, LEP/ELAP, SI, RIF-Reading, Consent Decree, Arts, Music, P.E., SF Ballet, Exploratorium, Zoo, Presidio, outdoor ed., grants from various donors
